This Waiver and Release Agreement is applicable to all houseboat owners, guests and users of the services provided by HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC, for all activities associated with embarking and disembarking the privately owned houseboat to include all activities on the property located at 612 Haul Rd, Page, AZ and all activities while performing the service of the launch and/or retrieval at Wahweap Marina, herein referred to "turn-around service". For purposes of this Waiver and Release, "HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC" includes all principles, directors, officers, employees, agents, representatives, successors, and insurers of HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC

**ACKNOWLEDGEMENT OF RISKS** – Although HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC has taken reasonable steps to provide a safe turn-around service, HOUSEBOAT MANAGEMENT SERVICES and/or LAKETIME **has informed me this activity is not without risk**. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of the turn-around service. The undersigned hereby acknowledges that some, but not all of the risks of participating in the turnaround service include: Vehicle collisions, slips and falls on/from the houseboat, slips and falls from staircases, exposure to inclement weather, insect or animal bites, and exposure to chemicals. The undersigned recognizes this is not a complete list of risks and that unknown or unanticipated risks may result in property damage, injury, illness or death.

**EXPRESS ASSUMPTION OF RISK** – The undersigned hereby agrees that he/she is accepting the turn-around service provided by HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC at his/her own risk. The undersigned agrees to assume and accept full responsibility for the inherent risks identified herein and those inherent risks not specifically identified.

**WAIVER/RELEASE OF LIABILITY** – By the execution of this Release, **the undersigned voluntarily release, forever discharges and agrees to indemnify and hold harmless** HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC from any and all liability of any nature for any and all injury or damages sustained by the undersigned, their guests or any minor children under the undersigned's custody, care, and control, as a result of any and all activities related to the turnaround service regardless of the cause. The **undersigned assumes full responsibility** for any such injuries or damages, which may occur, and further agrees that HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC shall not be liable for any loss or theft of personal property. The undersigned specifically agrees that **HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC shall not be responsible** for such injuries, damages, loss or theft EVEN IN THE EVENT OF NEGLIGENCE OR FAULT BY HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC.

**LIABILITY TO THIRD PARTIES** – The undersigned hereby agrees that he/she **will indemnify and hold harmless HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC for all personal injuries, property damages, or any other damages to any and all third parties**, including but not limited to owners and guests of other houseboats, guests and minor children (including minor children of guests) under the undersigned's custody, care and control as a result of any and all activities related to the turnaround service provided by HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC even if such damages arise out of the negligence or fault of HOUSEBOAT MANAGEMENT SERVICES, INC and/or LAKETIME, LLC.

**ACKNOWLEDGEMENT OF WAIVER AND RELEASE** – The undersigned warrants that he/she is fully aware that he/she **is waiving any right he/she may have to bring a legal action** to assert a claim against HOUSEBOAT MANAGEMENT SERVICE, INC and/or LAKETIME, LLC for any damages resulting from the referred to turn-around service.
